9. ORDINANCE— THIRD READING

Following ordinance read:

ORDINANCE NO. 9-22
AN ORDINANCE AMENDING SECTIONS 10.36.010 AND
10.36.020 OF CHAPTER 10.36 PARKING, OF THE CASPER
MUNICIPAL CODE.

The amendments to Section 10.36.010 indicated that Resolution No. 22-121 adopts the revised Parking Manual that stipulates parking options, prohibitions, limitations, fees, fines and regulations and exceptions. The amendments to Section 10.36.020 included amendments to stipulations on parkway parking, stating that it is unlawful to park a motor vehicle or RV within the city limits of Casper in a parkway, adjacent to a street, where at least two (2) twelve (12) feet travel lanes and two (2) eight (8) feet parking lanes can be maintained. Parkway parking where permitted, is subject to the rules and regulations of the City of Casper Parking Manual as updated, and to the requirement of a properly displayed permit.

Councilmember Knell presented the foregoing ordinance for approval, on third reading. Seconded by Councilmember Sutherland.

Individuals addressing the Council were: Bruce Dingle, 1617 S Poplar St.

Councilmembers Knell and Pollock discussed the importance of the ordinance, and Councilmember Cathey explained the amendment he made to the ordinance last week. Deputy City Attorney Trembath explained the difference between the ordinance and Homeowners Association rules regarding parkway parking. Vice Mayor Freel and Mayor Pacheco discussed why they were voting against the ordinance. Vice Mayor Freel and Mayor Pacheco voted nay. Motion passed.

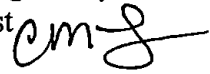

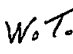

The general collection of the City's parking prohibitions, limitations, regulations, and exceptions are contained in Chapter 10.36 of the Municipal Code and the City of Casper's Parking Manual. In 2021, the Wyoming Liquor Laws regarding restaurants were amended. Restaurant liquor licenses now must have a dispensing area rather than a dispensing room. City Council will now approve a dispensing “area”, and the area will be age restricted to individuals 18 and over. No consumption can take place in this area.

The main requirement now is that meals must be prepared and served for on premises consumption. Previously, the service of “only fry orders” or sandwiches and hamburgers did not qualify an establishment as a restaurant. Pokes Investments, LLC plans to serve sandwiches and salads, beer, wine and digestives. Digestives are after dinner drinks such as brandies and whiskeys. If approved, this license will be active immediately.

As required by Municipal Code 05.08.070, a notice was published in a local newspaper once a week for two consecutive weeks. As required by State Statute 12-4-104(a) it is being advertised on the City’s website (www.casperwy.gov).

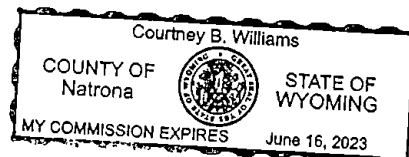

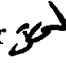

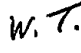

On December 18, 2012, City Council passed, approved, and adopted Ordinance No. 35-12, An Ordinance Granting a Franchise to WERCS Communications, Inc., D.B.A. Mountain West Telephone, for the Construction and Operation of a Telecommunications Service System. The term of the Franchise expired on December 18, 2020. The Franchisee, now known as Mountain West Technologies Corporation, and the City have continued to perform their obligations under the Franchise as if the Franchise term is still in effect.

The proposed ordinance, if passed, would:

1. Ratify the terms and conditions of Ordinance 35-12, as being in full force and effect from the time of the expiration of the term (December 18, 2020) until the proposed Ordinance is in full force and effect.
2. Extend the term of the Ordinance through April 26, 2037.
3. Allow the City and Franchisee to renegotiate the franchise fee up to four times during the term of the Agreement.

Financial Considerations

The City will continue to receive a 5% franchise fee on the locally generated portion of its revenue, subject to certain limitations. The City has received the following Franchise Fees for FY 2021 and FY2022:

FY 2021 \$5,941.83

FY 2022 \$7,406.69

The Franchisee will continue to provide a free wireless hotspot in the downtown area. Connection speeds will be at 5 Mb/s for download and 2 Mb/s for upload. The hotspot will extend westward from Kimball to Walnut, and southward from “C” Street to Collins Drive.

That Council, by resolution, accept a 20-foot permanent sanitary sewer easement, 20-foot temporary construction and access easement, and 30-foot permanent access easement from West Center Hospitality RE, LLC, as part of the North Platte Sanitary Sewer Rehabilitation, Project No. 20-015.

Summary

The City of Casper owns nine (9) miles of sanitary sewer trunk line known as the North Platte Sanitary Sewer (NPSS) interceptor. The line includes pipe diameters from twenty-four inch (24"), starting at 2600 Yarrow on the west end, up to fifty-four inch (54") along Bryan Evansville Road as the pipe enters the Casper Regional Waste Water Treatment Facility. Rehabilitation of this reinforced concrete pipe is scheduled to begin early this summer by Insituform Technologies, LLC, under the guidance of the City's consulting engineer, Jacobs Engineering. The project goal is to rehab or replace critical pipe sections while maintaining uninterrupted service and capacity in the system. The project includes approximately 7,600 feet of pipe rehabilitation using a cured-in-place liner, 14 new manholes to be installed, rehabilitation of two large interceptor structures, and miscellaneous items associated with the construction work. Construction of the improvements is to be substantially complete by April 7, 2023.

The NPSS has existed since the early 1980's but one un-platted parcel of land directly north of the Clarion Hotel had been overlooked in establishing easements for the sewer line. The easements included in this transaction will secure permanent legal access and maintenance for the NPSS.

Easements are necessary for ongoing access and maintenance of the sewer trunk line, as well as temporary construction access during roughly a year's time. Easement negotiations are now complete and the project will move into the construction phase. Construction on the parcels of land owned by the Clarion Hotel includes approximately 850 feet of pipe rehabilitation using the cured-in-place liner, and two manhole replacements.

Due to this existing sewer pipeline infrastructure being in place since the early 1980's and its ongoing use and operation, no exchange of funds will be involved in this transaction between the parties.

SANITARY SEWER EASEMENT

KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and confessed, the parties agree as follows:

1. WEST CENTER HOSPITALITY RE LLC, A WYOMING LIMITED LIABILITY COMPANY, hereinafter referred to as "Grantor", hereby grants to CITY OF CASPER, A MUNICIPAL CORPORATION, and its successors and assigns, as "Grantee" the right to: (a) a 20-foot wide perpetual sanitary sewer easement in accordance with the terms contained herein; (b) a 20-foot wide temporary construction and access easement in accordance with the terms contained herein, and (c) a 30-foot wide permanent access easement in accordance with the terms contained herein, with such easements being located in and across the following described land located in the County of Natrona and State of Wyoming, to-wit:

The property described and/or shown in the attached EXHIBIT "A" and EXHIBIT "B", said Exhibits being incorporated herein at this point as if fully set forth.

- a. A 20-foot wide perpetual sanitary sewer easement is conveyed to Grantee for sewer purposes and for the purpose of permitting Grantee to construct, lay, operate, and maintain a sanitary sewer and related facilities on such easement area. After any construction and/or maintenance of such sanitary sewer and related facilities, Grantee agrees to see that the surface of the easement area is restored to as near the same condition as practicable by the Grantee. Related to such 20-foot wide perpetual sanitary sewer easement, Grantee is authorized hereunder to remove and keep removed from the easement all trees, vegetation, and other obstructions as necessary to maintain, repair, or protect said sanitary sewer and related facilities. This easement shall not prohibit Grantor from (1) constructing, maintaining, and/or using the easement area for paved or unpaved drives and parking areas; and (2) planting and maintaining shallow-rooted ground cover material within the easement area, all subject to applicable laws and regulations. All risk of damage to such improvements caused by maintenance or repair of the sanitary sewer and related facilities shall be with the Grantor.
- b. A 20-foot wide temporary construction and access easement is conveyed to Grantee to use for all things reasonably necessary for the construction and installation of the sanitary sewer and related facilities including, but not limited to, the transport, stockpiling, and storage of construction materials, soil, equipment, and vehicles. This 20-foot wide temporary construction and access easement shall automatically terminate upon the earlier of: (1) the date that is ninety (90) days after the date the construction of the sanitary sewer and appurtenances is accepted

and recognized as complete by the Grantee; or (2) August 31, 2023. Prior to the termination of this easement, Grantee, at its sole cost and expense, shall restore the easement area to substantially the same condition it was in prior to Grantee's use as provided herein. Grantee shall not leave any rubbish or debris on or about the easement area.

- c. A 30-foot wide permanent access easement is conveyed to Grantee for free and unobstructed right of ingress and egress over the easement area for the purpose of maintaining, repairing, operating, and replacing the sanitary sewer and facilities located on the 20-foot wide perpetual sanitary sewer easement as detailed in paragraph "(a)" above. After each use of the easement area, Grantee agrees to see that the surface of the easement area is restored to as near the same condition as practicable by the Grantee. This easement shall not prohibit the Grantor from (1) constructing, maintaining, and/or using the easement area for paved or unpaved drives and parking areas; and (2) planting and maintaining landscaping within the easement area, all subject to applicable laws and regulations. All risk of damage to such improvements caused by maintenance or repair of the sanitary sewer and related facilities shall be with the Grantor.

2. Nothing herein shall be construed to grant to Grantee any right of access through or over any other property of Grantor except that lying within the easements herein described and conveyed. Grantor shall retain fee simple ownership of the property through and over which this easement passes.

3. 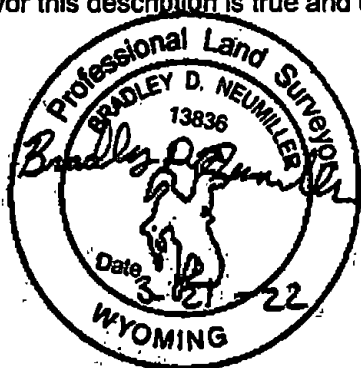

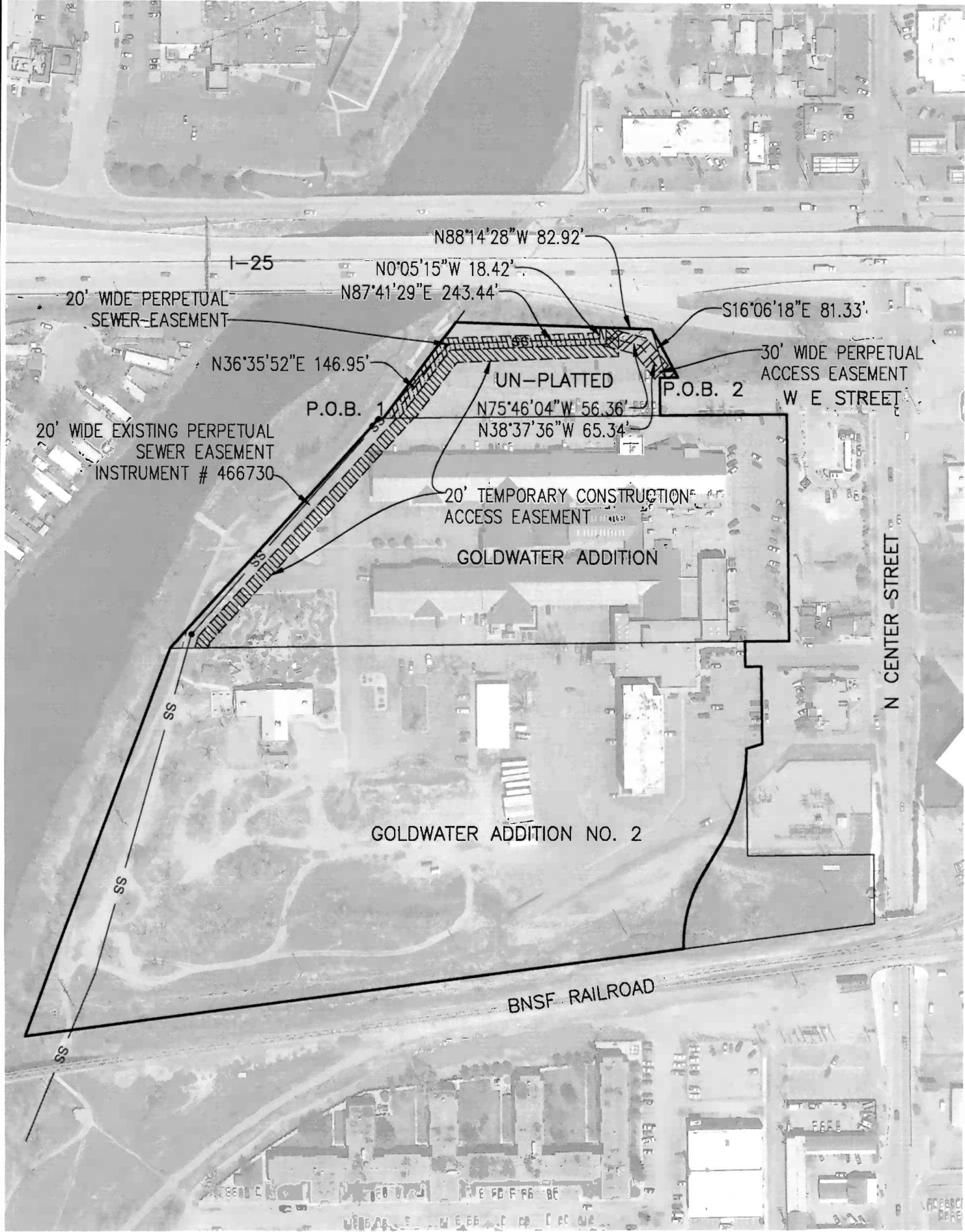

Recommendation:

The Planning and Zoning Commission recommends that Council, by resolution, approve the vacation and replat creating Centennial Hills Village Business Park No. 4.

Summary:

Application has been received for a proposed vacation and replat of Lot 1D in the Centennial Hills Village Business Park No. 3 Subdivision, to create Centennial Hills Village Business Park No. 4. The property totals 6.10-acres, is currently undeveloped, and is zoned PUD (Planned Unit Development). The Centennial Hills PUD (Planned Unit Development) was created in 2003, and has been amended multiple times through the years. Most recently, in October of 2019, the PUD Guidelines were amended to create commercial development guidelines for the subject area of this request. The proposed replat is splitting the 6.10-acre parcel into two (2) lots. Proposed Lot 1 is approximately 2 acres in size, and proposed Lot 2 is approximately four (4) acres.

During the approval of the commercial PUD development guidelines for this area, there was significant discussion about the compatibility of the commercial area with the residential area directly to the east. As a result, the points of access to the property were limited to a total of three (3). The intent of the limitations was to force internal traffic circulation rather than having traffic entering and exiting along the entire length of the property's Heathrow Avenue frontage. Staff recommended, and the Planning and Zoning Commission approved, a recommended condition that reiterates this requirement.

A second recommended condition of approval has also been included by the Planning and Zoning Commission, as recommended by staff, which requires the property owner to participate in the construction of a sidewalk along the Wyoming Boulevard frontage of the subdivision, as required under Section 16.16.020 of the Municipal Code. The Casper Area Metropolitan Planning Organization (MPO) commissioned the "Wyoming Boulevard Sidepath Study and Conceptual Design" in 2013. The study is the basis for current efforts by the City to identify and obtain funding for the construction of a pedestrian trail along the entire circumference of Wyoming Boulevard. Given the size and scope of the project and the Ten Million Dollar-plus estimated cost, it will need to be completed in several phases. Funding is likely to come from a number of sources, including

grants, donations, traditional trail funding mechanisms such as One Cent Funds, as well as participation by adjacent property owners/developments. The “Wyoming Boulevard Sidepath Study and Conceptual Design” can be viewed on the City/MPO website, under the “Past Project Index.”

The Planning and Zoning Commission voted to support the vacation and replat after a public hearing on June 16, 2022. There were no public comments at the public hearing.

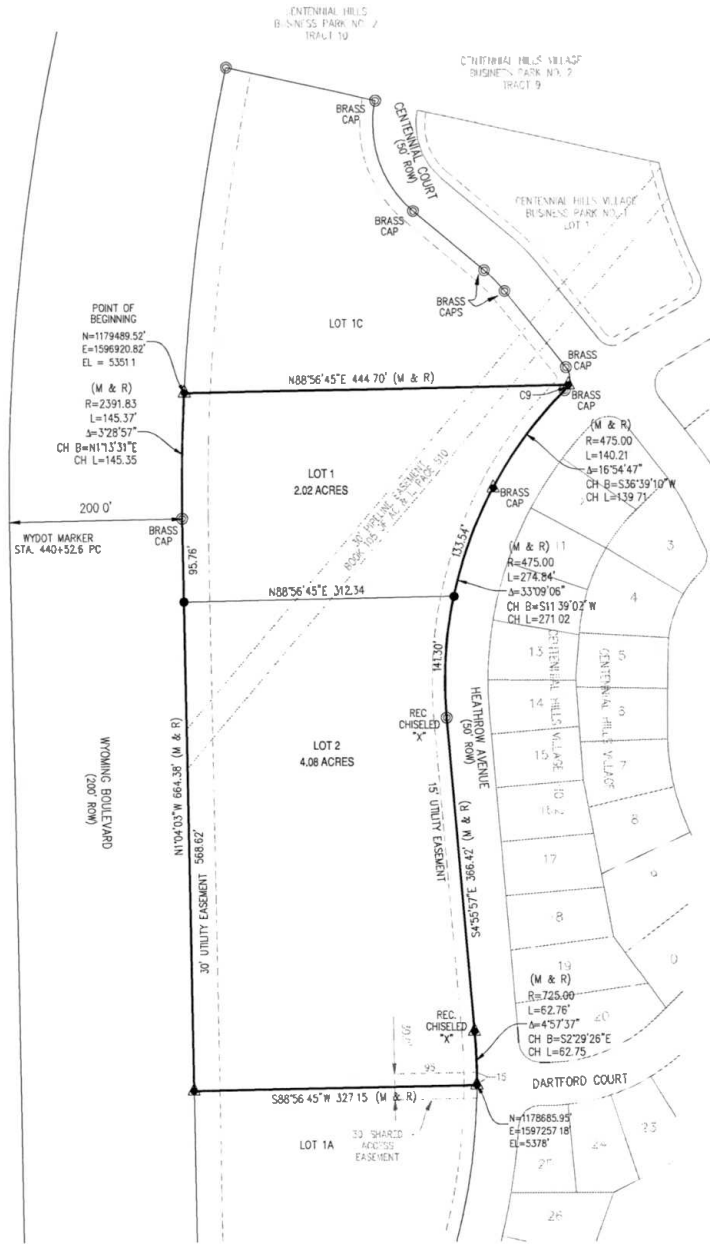

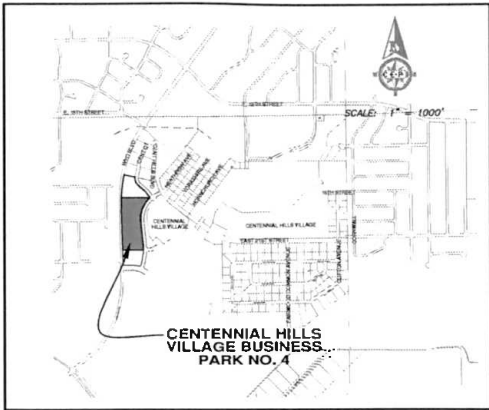

- B. Owner has applied for a vacation and replat of Lot 1D, Centennial Hills Village Business Park No. 3, to create Centennial Hills Village Business Park No. 4.
- C. A plat of Centennial Hills Village Business Park No. 4 ("Addition") has been prepared by the Owner, and approved by the City of Casper, and shall be signed and recorded at the Natrona County Clerk's Office concurrently with this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, the parties hereto agree as follows:

SECTION 1 – INCORPORATION OF RECITALS

The recitals set forth above are incorporated at this point as if fully set forth as part of this Agreement.

SECTION 2 - OBLIGATIONS OF OWNER

Upon written demand of the Council or the City Manager, the Owner, its heirs, successors, grantees or assigns, at their sole cost and expense, shall do, or cause to be done, the following:

2.1 Surveying:

- a. All subdivision corners shall be marked with 3¼ brass caps. These caps shall show the name of the surveyor or company making the survey, and the license number of the surveyor making the survey or certifying the survey. All PLSS corners shall be properly marked for identification as to the location in accordance with Wyoming Statutes and Rules and Regulations of the Wyoming Board of Registration for Professional Engineers and Professional Land Surveyors, shall be referenced if subject to destruction, and again shall show the proper identification and license of the certifying surveyor. A corner record shall be recorded as per Wyoming Statutes and Rules and Regulations of the Wyoming Board of Registration for Professional Engineers and Professional Land Surveyors. A copy will be provided to the City upon recordation.
- b. Block and Lot corners, points of tangency (PT's) and points of curve (PC's) of all curves shall be marked by an iron pin not less than five-eighths (5/8) inches in diameter and not less than twenty-four (24) inches in length, with a brass or aluminum cap not less than 2 and one-half (2½) inches in diameter securely fastened to the top, unless otherwise impractical. These monuments will be set prior to the recording of the plat in the Office of the County Clerk unless approved by the City Surveyor.
- c. Said corners shall be in place for final inspection by the Public Services Director upon completion of the sidewalk (curbwalk), or curb and gutter.
- d. A digital copy of the Final Subdivision Plat shall be provided to the City, as required by the Casper Municipal Code ("Code"). No building permit shall be issued prior to the recording of the plat.

2.2 Construction Sequence:

Main water lines, sewer lines, storm sewer, streets, sidewalks, pavement overlays, and access drives shall be constructed in an orderly sequence, as the Addition is developed and built upon, so that there will be no gaps left in the paving, sidewalks, and other off-site improvements. Streets shall not be paved until all water lines, storm sewers, and property water and sewer services are in place and the ditches thereof properly backfilled and compacted, in accordance with City requirements. The Owner shall receive the approval of the Public Services Director prior to commencing any and all phases of construction.

2.3 Certification of Construction; Repair Obligations:

- a. All improvements shall be designed and inspected by a Wyoming registered professional engineer, who shall certify that the improvements, including, but not limited to, streets, curbs, gutter, sidewalks, paving, parkways, utility systems, storm sewers, street lighting, street signs and

striping, etc., have been constructed in accordance with plans and specifications approved by the Public Services Director. The certification by the engineer and approval by the City shall be in writing. Approval of the construction plans by the Public Services Director is required before a building permit will be issued by the City.

- b. The Owner shall maintain, repair, and replace all improvements that fail within the warranty period as provided by the Code. This obligation includes maintenance, repair or replacement for any cause during such period, including acts of subcontractors. In the event the Owner fails to maintain, repair, or replace said improvements, the City shall have the right but not the obligation, at its option, to maintain, repair, or replace the same and Owner agrees to pay for any cost incurred thereby. Maintenance, repair, or replacement by the City does not relieve the Owner from its obligation under this paragraph and shall not be construed to be an acceptance of the improvements by the City.
- c. Upon issuance of a "letter of acceptance" by the Public Services Director pursuant to the Code, the City will assume ownership and the responsibility for the maintenance of the improvements. The Owner shall be responsible for the maintenance, repair and replacement of the improvements until the City issues its "letter of acceptance."

2.4 Underground Utilities and Street Lights:

All new utilities shall be located underground. All street lights shall be installed in compliance with Code street-lighting standards at the Owner's sole expense. Streetlight pole materials shall be as approved in writing by the Public Services Director.

2.5 Soils Analysis:

The Owner shall provide the Public Services Director with a soils analysis concurrently with the submittal of subdivision construction plans. Individual lot test bores may be required on each lot, with a soil analysis for the foundation design at the sole discretion of the Public Services Director. Test results, soil analyses and foundation designs shall be submitted to the Community Development Director.

2.6 Erosion Control Program:

- a. The Owner shall submit, and have approved by the Public Services Director, a comprehensive erosion control program for the area disturbed during construction activities to mitigate the adverse effects of blowing dirt or dust, and water erosion on other properties in the immediate area before the issuance of an earthwork, road cut or grading permit pursuant to the Code. An erosion and sediment control permit shall be obtained

from the Public Services Director prior to any earthwork taking place in the Addition.

- b. The Owner shall post security for its erosion control as required by the Code, and in a form acceptable to the City. It shall be the obligation of the Owner to keep any security in full force and effect, as required by the Code. In addition, the Owner shall furnish proof of the same to the Public Services Director upon demand of the City.

2.7 Retaining Walls and Fences:

Any retaining walls constructed within the subdivision by the Owner shall be designed and certified by a Wyoming registered professional engineer. The design(s) shall be submitted to the Public Services Director and Community Development Director for written approval before a building permit will be issued. Said walls shall be constructed within the boundaries of each lot and not on the property lines. Maintenance of said walls shall be the responsibility of each individual lot owner. Provided, however, retaining walls and fences shall not be constructed on any drainage easements, or on any other ways depicted on any other recorded instrument without the approval of the Public Services Director.

2.8 Water and Sewer:

All water and sewer improvements shall be constructed in full compliance with the Code as it exists at the time of construction, including, but not limited to the following requirements:

- a. Curb boxes shall be left behind the sidewalk in front of each lot and the Owner shall protect, during the subsequent course of developing the Addition, valve boxes and curb boxes from damage, and be wholly responsible for the repair and replacement to the Public Services Director's satisfaction of such that are damaged or destroyed. If the Owner shall fail or refuse to promptly repair or replace such boxes as required, the City may do so and charge the Owner directly for said cost. The Owner shall adjust said valve and curb boxes to finished grade, at the time the paving work is completed in the Addition.
- b. The Owner shall construct the necessary water lines and appurtenances up to and through the Addition. All work shall be in accordance with plans and specifications to be prepared by the Owner's engineer and approved in writing by the Public Services Director. Water line sizes shall be as determined by the Public Services Director.
- c. The Owner, at its cost, shall install water service lines in accordance with Code specifications to the property line so as to serve each lot or building site in the Addition.

- d. The Owner shall construct the necessary sewer lines up to and through the Addition. All work shall be in accordance with plans and specifications to be prepared by the Owner's engineer and approved in writing by the Public Services Director. Sewer sizes shall be as determined by the Public Services Director.
- e. The Owner, at its own cost, shall install sewer service lines, in accordance with Code specifications, to the property line so as to serve each lot or building site in the Addition.
- f. The Owner shall protect manhole covers and rings from damage in the course of constructing the line, and shall be solely responsible for repair or replacement to the Public Services Director's satisfaction. The Owner shall adjust such manhole rings and covers to finished grade. The Owner agrees to protect and save the City harmless from any loss or claim suffered by other sewer users to their real or personal property, and from personal injury or damages by reason of obstruction or damage to the sewer lines or any part thereof occasioned by present or future construction work on said Addition by the Owner. Said obligation shall continue until the sewer line and the system within the Addition is accepted by the Public Services Director by issuance of a "letter of acceptance." Provided, however, that acceptance of part of the system shall not relieve the Owner of the obligations herein imposed for the remaining improvements that have not been accepted within said Addition.
- g. Prior to the issuance of a building permit for any new structure, or prior to the issuance of a plumbing permit to connect existing buildings to the water and sewer systems, the then-existing water system investment charge (connection charge), sewer system investment charge (connection charge) and water meter charge shall be paid to the City. The Owner will also pay to the Central Wyoming Regional Water System Joint Powers Board the then current Regional Water System investment charge for each building to be served with water.
- h. All necessary water and sewer easements, in forms acceptable to the City, up to and through the subdivision shall be obtained by the Owner, which grant to the City the right of ingress and egress thereto for purposes of laying out, constructing, inspecting, maintaining and replacing water lines, sewer lines, its fire hydrants and other appurtenances.
- i. The Owner agrees to abide by all federal, state and local laws, rules and regulations regarding the use of its water and sewer facilities, and water and sewer service, including, but not limited to, the Federal Pretreatment Regulations and all the Code sections relating to industrial pretreatment.
- j. At such time as said water and/or sewer mains are installed by the Owner and a "letter of acceptance" is issued by the Public Services Director, the City shall pursuant to the Code, reimburse the Owner twice the difference in material cost between an eight (8) inch water and/or sewer main, or larger size if required by the development, and the required oversized main pursuant to the Code, as

amended. Such reimbursement will be determined by the City based upon its most recent applicable material costs at the time of the Agreement execution. Reimbursement will only be based on oversizing of water and sewer mains larger than the size required by system analysis and approved by the Public Services Director.

2.9 Easements for all Utilities, Bikeways and Pedestrian Pathways:

Easements for all utilities and future bikeway/pedestrian pathways and access, in recordable forms acceptable to the City, must be provided prior to application for a permit to construct being made to the City. Mid-block pedestrian ways are required under Casper Municipal Code Section 16.16.020(B) for blocks over five hundred feet (500') in length. Those shall be maintained in good repair for use by the public by the property owners located immediately adjacent thereto. The immediately adjacent property owners are responsible for all costs and expenses thereof.

2.10 Street and Traffic Signs and Controls:

Owner shall pay for the cost and installation of all necessary on and off-site street and traffic control signage, signs signifying the street names, street striping, crosswalk striping, and traffic calming devices, as determined by the Public Services Director in his sole discretion.

2.11 Security Requirements:

In addition to and separate from the security required for erosion control, Owner shall comply with all Code requirements for all other security and surety requirements as set forth in the Code, including, but not limited to the financial surety and security for the project, landscaping and warranty period.

2.12 Record Drawings:

- a. Owner shall submit "as-built" record documents for paving, drainage, water and sewer to the City prior to the issuance of the certificate of occupancy. Reproducible hard copy drawings shall be in the form of one (1) set of 4, mil Mylar, 24" x 36" labeled as "Record Drawings" and dated. Record Drawings shall also be provided on electronic media in Adobe (pdf) format and in AutoCAD format or other format specified by Owner. Record documents shall be submitted on CDs, or other media as directed by Owner, labeled as "Record Drawings" and include the project name, City of Casper project number and date.
- b. All digital files necessary for correct plotting of the final record drawings in the AutoCAD version, such as external references, pen assignments, images, etc. shall be provided. Any x-refs or other files that can be, shall be incorporated into the final drawings to minimize the manipulation necessary for plotting.

2.13 Completion of Infrastructure Improvements Prior to Certificate of Occupancy:

All required on-site and off-site improvements shall be completed and approved by the Public Services Director prior to the issuance of the first certificate of occupancy unless otherwise designated in this Agreement.

2.14 Other Costs in Separate Agreements:

If any recapture costs, costs for a drainage basin or sub-basin wide stormwater management program are applicable to this Subdivision, those costs shall be allocated in a separate exhibit attached to this Agreement. Failure of any such exhibit to be attached to this Agreement shall not relieve the Owner of its obligation to pay its proportionate share of those costs

2.15 Stormwater, Flooding and Letters of Map Revisions:

- a. Owner shall comply with and pay for all costs associated with any Stormwater Pollution Prevention Plan, Letter of Map Revision (LOMR), or other related requirements of Wyoming DEQ, Federal Emergency Management Agency (FEMA) or any other agency that has jurisdiction over the real property in impacted by this Agreement.
- b. Owner shall provide the City with copies of all Stormwater Pollution Prevention Plan elements as reviewed and approved by Wyoming DEQ; any LOMR, along with the necessary submittals to update flood mapping in accordance with FEMA requirements, and documentation of Base Flood Elevations.
- c. All requirements of this section shall be met prior to issuance of a permit to construct subdivision improvements.

2.16 Other Requirements:

- a. Pursuant to Section 16.16.020(M) of the Casper Municipal Code, the only points of vehicular access that will be permitted to serve the subdivision are those shown on the approved Centennial Hills PUD (Planned Unit Development) Guidelines, as amended October 1, 2019. Internal cross access and shared parking are accommodated via a Parking and Reciprocal Access Easement Agreement recorded at the Natrona County Clerk's Office as Instrument #1104487.
- b. Pursuant to Section 16.16.020(S) of the Casper Municipal Code, in commercial areas, curb, gutter and sidewalk/curbwalk shall be required on both sides of public streets. Therefore, in accordance with this obligation, Owner shall participate in a proportionate share of the cost of the construction of standard City sidewalk along the Wyoming Boulevard frontage of the subdivision if/when directed by the City of Casper at an undetermined time in

the future. If said sidewalk/pathway is proposed to be constructed as a part of a Local Assessment District (LAD), Owner shall not oppose the formation of said LAD.

SECTION 3 - OBLIGATIONS OF CITY

The City shall issue a building permit and certificate of occupancy for the buildings in the Addition upon performance by the Owner of the conditions set forth herein, and upon Owner's compliance with all applicable Code requirements. All building permits will be issued by the Community Development Director in accordance with the Code

SECTION 4 - REMEDIES

In the event the Owner fails to do, or fails to cause to be done, any of the requirements set forth in this Agreement in an expeditious manner, the City may, at its option, do any or all of the following.

- a. Refuse to issue any building permits or certificates of occupancy to any person, including the Owner, or its heirs, successors, assigns and grantees.
- b. After written notice to the Owner of any public improvements which have not been completed or properly completed, and upon Owner's failure to cure the same within a reasonable period of time, the City may complete any and all of the public improvements required by this Agreement by itself or by contracting with a third party to do the same. In the event the City elects to complete said improvements, or contracts with a third party to do so, the Owner agrees to pay any and all costs resulting therefrom upon demand by the City.

The remedies provided in this section are in addition to any other remedies specifically provided for in this Agreement, or which the City may otherwise have at law or in equity, and are not a limitation upon the same. The Owner further agrees to pay all reasonable attorneys' fees, court costs, and litigation costs in the event the City is required to enforce the provisions of this Agreement in a court of law.

SECTION 5 – GENERAL PROVISIONS

- a. Successors and Assigns: The terms and conditions of this Agreement shall be binding upon the parties hereto, and shall inure to the benefit of all parties hereto and their respective heirs, successors, assigns, and grantees and shall bind and run with the real property that is the subject matter of this Agreement. The Owner shall not assign this Agreement or otherwise sub-contract its duties and responsibilities as set forth in this Agreement without the prior written consent of the City.

- b. Wyoming Governmental Claims Act: The City does not waive any right or rights it may have pursuant to the Wyoming Governmental Claims Act, Wyoming Statute Sections 1-39-101, *et seq.* The City specifically reserves the right to assert any and all immunities, rights, and defenses it may have pursuant to the Wyoming Governmental Claims Act.
- c. Governing Law and Venue: This Agreement, its interpretation and enforcement shall be governed and construed in accordance with the laws of the State of Wyoming. Any litigation regarding this Agreement shall be resolved in a court of competent jurisdiction situated in Natrona County, Wyoming.
- d. Complete Agreement: This Agreement shall constitute the entire understanding and agreement of the parties, and supersedes any prior negotiations, discussions or understandings.
- e. Amendment: No amendment or modification of the terms of this Agreement shall be valid or enforceable unless made in writing and executed by all parties hereto.
- f. Waiver: Failure on the part of either party to enforce any provision of this Agreement, or the waiver thereof, in any instance, shall not be construed as a general waiver or relinquishment on its part of any such provision, but the same shall nevertheless be and remain in full force and effect.
- g. No Third-Party Beneficiary Rights: The parties to this Agreement do not intend to create in any other individual or entity the status of third-party beneficiary, and this Agreement shall not be construed so as to create such status. The rights, duties and obligations contained in this Agreement shall operate only between the parties to this Agreement, and shall inure solely to the benefit of the parties to this Agreement. The parties to this Agreement intend and expressly agree that only parties signatory to this Agreement shall have any legal or equitable right to seek to enforce this Agreement, to seek any remedy arising out of a party's performance or failure to perform any term or condition of this Agreement, or to bring an action for the breach of this Agreement.
- h. Severability: If a court of competent jurisdiction renders any provision of this Agreement (or portion of a provision) to be invalid, illegal or otherwise unenforceable, that provision or portion of the provision will be severed and the remainder of this Agreement will continue in full force and effect as if the invalid provision or portion of the provision were not part of this Agreement.
- i. Notices: Notices required or permitted to be given by a Party to the others must be in writing and either delivered in person or sent to the address shown below (or such subsequent address as may be designated by

either party in writing) by certified mail, return receipt requested and postage prepaid (or by a recognized courier service, such as Federal Express, UPS, or DHL), or by facsimile with correct answerback received, and will be effective upon receipt:

- j. Headings: The section headings contained in this Agreement are for reference purposes only and shall not affect in any way the meaning or interpretation thereof.
- k. Survival: All representations, indemnifications, warranties and guarantees made in, required by or given in accordance with this Agreement, as well as all continuing obligations indicated in this Agreement, will survive final payment, completion and acceptance of the services and termination or completion of the Agreement.
- l. Copies: This Agreement may be executed in more than one copy, each copy of which shall serve as an original for all purposes, but all copies shall constitute but one and the same Agreement.
- m. Authority: Each individual executing this Agreement for and on behalf of their principals hereby state that they have the requisite power and authority to enter into this Agreement and to consummate the transactions contemplated and intended hereby. Owner further states that it is authorized to transact business in the State of Wyoming, properly registered and not delinquent with the Secretary of State.
- n. Term: At the time the Owner files for a permit to construct, the then applicable code provisions shall apply for the life of the permit or under an extension that is approved by the Public Services Director. If the Owner fails to file for a permit to construct at the time of platting, all applicable provisions of the Code that have changed since the execution of this Agreement shall be required of the Owner at the time of permit application, and the City at its sole discretion may require a new Subdivision Agreement and/or the replatting of property. Provided, however, Code amendments pertaining to the health and safety of the public shall be complied with by the Owner during the term of this Agreement, regardless of the validity of the permit to construct.

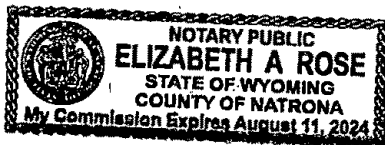

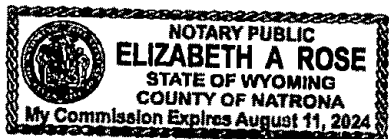

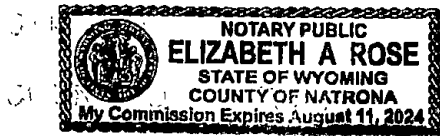
