Recommendation:

That Council authorize the sole source purchase of two Flygt Pumps from Water Technology Group in the amount of \$79,112 for use at the Bar Nunn #1 & #2 Lift Stations.

Summary:

The Bar Nunn #1 and Bar Nunn #2 lift stations, located near Salt Creek Highway in Bar Nunn, collect and pump wastewater generated from the residential and industrial areas west of I-25 through 8-inch and 10-inch force mains, respectively. Flows are then conveyed to the Regional Wastewater Treatment Facility.

The pumps at these lift stations are 10 years old and have lost significant pumping capacity. The components to be replaced include:

• 2 - Flygt Submersible Wastewater Pumps

The Public Services Department is requesting the purchase of the pumps and appurtenances through Water Technology Group. The reasoning is as follows:

- 1. The City and Regional Wastewater System have, over the years, successfully standardized the pumps, control panels, and appurtenances used in Casper wastewater lift stations to high quality Flygt equipment, resulting not only in improved reliability, but also in the added benefits of better staff familiarity of equipment and the interchangeability of spare parts, pumps, and backup equipment.
- 2. A sole source request is necessary because Water Technology Group is the only distributor in Colorado and Southern Wyoming authorized to sell, service, and install Flygt products to

local government agencies. Flygt has set this program in place to ensure municipalities have a stable working relationship with their respective distributor and to promote accuracy gained through historical product placement and service. Municipalities do benefit from a discounted materials cost compared to contractors and other direct industrial and commercial customers through this designated distributor program. Casper has had 30 plus years of very good experience with Water Technology Group.

The Public Services Department requests that the sole-source purchase be made for the replacement of the pumps, providing more efficient and cost effective reliability of service at these lift stations. City crews will install the equipment in the station later this year.

Financial Considerations

Funding for the project will come from Wastewater Treatment Plant Fund Reserves.

Furniture Properties

Meeting Type & Date: Council Work Session, January 22, 2019.

Action Type: Council Direction requested.

Recommendation: That Council review and consider Addendum #2 to the RFP to sell the various properties in the former Plains Furniture block.

<u>Summary:</u> Staff has been approached by an interested party who wishes to purchase the former Livery Stable in the Plains Furniture block, and who would also like to purchase the parking lot south of the former Plains Furniture block as part of a development proposal. Addendum #1 to the original RFP was issued on November 29, 2018, to give notice that the parking lot parcel would be available for purchase in conjunction with a proposal to purchase any, or all, lots associated with the former furniture store. The former livery stable property was not listed in that Addendum, and this was an oversight. Staff has prepared Addendum #2 to include it, and seeks Council's approval to issue it. No other changes have been made. The properties, which were purchased by the City in January 2016, are located on South David Street, between West Yellowstone Highway and West Midwest Avenue, and the former livery stable located in the same block on South Ash Street in the Old Yellowstone District.

Financial Considerations: Any revenues from the sales of the properties would be captured in the FY19 Revolving Land Fund account, unless directed otherwise by Council.

Oversight/Project Responsibility: Community Development Department/Planning Division.

All other submittal requirements remain the same.

The purpose of this Addendum is to give notice that an additional parcel of land, the vacant land described herein to the south of the former Plains Furniture store shall also be available for purchase and development in conjunction with a successful proposal to purchase one or more of the former Plains property structures, Parcels 1, 2 and/or 3, and/or the former Livery Stable property – (See Exhibit B to the original Request for Proposals). This property to the south of the former Plains Furniture store will be referred to as "parking lot" in this Addendum to the RFP.

The legal description of the "parking lot" is:

Lots 23, 24, 25, and 26, Block, Original City of Casper, Natrona County, Wyoming.

Amount of Bid: each Contractor shall identify the amount they are willing to pay for the purchase of each specific property, including the "parking lot" as indicated in the Request for Proposal and this Addendum to Request for Proposal. Property appraisals are available by contacting the City of Casper Community Development Department at (307) 235-8241. Offers must meet or exceed appraised values.

Confidential Information.

- a. Under the Wyoming Public Records Act, Wyoming Statutes (W.S.) § 16-4-201 et seq., responses to a Request for Proposal (RFP) submitted to the City are generally available for inspection. Confidential Information also does not include any information that: is or becomes publicly known through no wrongful or negligent act of the City; is already known to the City without restriction when it is disclosed; is, or subsequently becomes, rightfully in the City's possession without any obligation restricting disclosure; is independently developed by the City; or is explicitly approved for release by your written authorization.
- c. The City will not disclose any provided material or information identified as Confidential Information to third parties without your prior written permission, unless you make such material or information public or disclosure is required by law. If the City is required by law to disclose such confidential information, it will notify you prior to such disclosure.
- d. The City may use the Confidential Information received only in analyzing and making a determination about the responses to the RFP, and for its own business purposes.
- e. Confidential Information is and will at all times remain the property of the disclosing party, and no grant of any proprietary rights in the Confidential Information is given or intended by your response to the RFP.
